

## **ORDINANCE NO. 2025.01**

### **AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY OF FONTANELLE, IOWA, BY AMENDING PROVISIONS PERTAINING ELECTRIC RATES SECTION 111.05**

**BE IT ENACTED** by the City Council of the City of Fontanelle, Iowa:

**SECTION 1. SECTION MODIFIED.** Section 111.05 of the Code of Ordinances of the City of Fontanelle, Iowa, is repealed and the following adopted in lieu thereof:

**111.05 RATES.** The rates for electric service shall be as follows:

1. Residential Rate:  
Meter Charge - \$16.00  
Effective 1-1-25 flat rate of \$.103 per kWh  
Effective 1-1-26 flat rate of \$.1105 per kWh
2. Rural Residential Rate:  
Meter Charge - \$20.00  
Effective 1-1-25 flat rate of \$.103 per kWh  
Effective 1-1-26 flat rate of \$.1105 per kWh
3. Commercial Rate:  
Meter Charge for Single-Phase - \$29.00  
Meter Charge for Three-Phase - \$41.00  
Effective 1-1-25 flat rate of \$.103 per kWh  
Effective 1-1-26 flat rate of \$.1105 per kWh
4. Rural Commercial Rate:  
Meter Charge for Single-Phase - \$33.00  
Meter Charge for Three-Phase - \$45.00  
Effective 1-1-25 flat rate of \$.103 per kWh  
Effective 1-1-26 flat rate of \$.1105 per kWh
5. Government Rate:  
Meter Charge for Single-Phase - \$29.00  
Meter Charge for Three-Phase - \$41.00  
Effective 1-1-25 flat rate of \$.103 per kWh  
Effective 1-1-26 flat rate of \$.1105 per kWh

**SECTION 2. SEVERABILITY CLAUSE.** If any section, provision, or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision, or part thereof not adjudged invalid or unconstitutional.

**SECTION 3. WHEN EFFECTIVE.** This ordinance shall be in effect from and after its final passage, approval, and publication as provided by law.
