and Reed. Absent: none. All motions are carried unanimously unless otherwise noted. City employees present: David Sickles and Susan Newton. Also present: Terri Queck-Matzie, and Denny

Sickles.Mayor Jensen declared the public hearing for the FY 2016 budget open.Terri Queck-Matzie discussed request from the Enterprise Club to contribute \$3,500.00 for fireworks for

the upcoming celebration. The entire cost of the fireworks will be \$5,000.00. Motion by Warrior to approve the request, 2nd by Shafer. Approved.Denny Sickles presented 2 quotes he

had received for a replacement fire truck. Toyne had bid \$258,640 for a truck with a 1,250 gallon tank. Feld's bid was \$249,840 with a 1,000 gallon truck. He is still waiting for a

firm bid from Alexis. Denny stated he would prefer a 1,250 gallon tank. Motion by Reed to commit \$100,000.00 of LOST funds to purchasing a new fire truck. 2nd by Sickles. Approved.

Susan will try to schedule a fire and rescue meeting for Monday, February 16th to discuss the purchase further.

The mayor opened the mowing and spraying bids received.

amount as requested. 2nd by Warrior. Approved.Reviewed the completed operator-in-charge contract with Greenfield Municipal Utilities to provide licensing for water and wastewater operations.

Mayor Jensen signed the contracts as approved last month. Reviewed a quote Susan had received for LED solar powered stop sign lights for in front of the middle school. Some citizens

had complained the stop signs were "too hard to see." The quote Susan obtained was for \$1,525.00 per stop sign, for a total of \$3,050.00. We need solar powered signs as there is no

electric service available. After some discussion, Susan was requested to contact the school and see if they would be willing to split the cost of the signs. No one present had any comments

on the budget, so Mayor Jensen closed the budget public hearing at 7:30 p.m.
