April 13, 2015 The Fontanelle City Council met in regular session at 7:02 p.m. with Mayor Jensencalling the meeting to order. Council members present were: Shafer, Sickles, Warrior, and

Reed. Absent: Dukes. All motions are carried unanimously unless otherwise noted. City employees present: David Sickles and Susan Newton. Also present: Jerry and Marlene Davis, Rodney

and Debra Dukes, and Wayne Miller. Motion by Sickles to approve the agenda with the addition of waiving community center rent for fire department fund raiser. 2nd by Reed. Approved. Motion

by Sickles to approve a building permit for a garden shed for John Marnin, and a machine shed for Curt Queck. 2nd by Reed. Approved. Resolution 2015.11: Resolution Appointing Fontanelle

Representative to Serve as Commissioner of the Southern Iowa Regional Housing Authority. Harvey Wallace has decided he does not wish to serve any longer. Jerry Davis agreed to the appointment.

Reed introduced the resolution and moved its adoption, seconded by Shafer; and after consideration by the City Council, the Mayor called roll and the following named Council Members

voted Aye: Reed, Sickles, Warrior, and Shafer. Whereupon, the Mayor declared the motion carried and the resolution adopted. Reviewed the proposed budget amendment prepared by Susan.

The water main replacement project's start date was delayed and more of the project costs were incurred in this fiscal year. Motion by Warrior to publish the amendment and schedule

the public hearing for May's council meeting. 2nd by Shafer. Approved. Discussed raises for Susan Newton, Pat Henry and Lynn Eddy for fiscal year 2015/2016. Motion by Reed to increase

their wages by \$.50/hour. 2nd by Sickles. Approved. Police Department report prepared by Pat Henry was reviewed. Pat reported the city's preliminary breath tester is outdated. He requested

to be allowed to purchase a replacement, which would cost approximately \$375.00. This purchase was approved. Motion to approve the minutes, clerk's report and list of bills by Reed,

2nd by Shafer. Approved.
