RESOLUTION NO. 8-1972  
RESOLUTION TO ADOPT THE MUNICIPAL BUDGET  
FOR THE YEAR 1973

BE IT HEREBY RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF FONTANELLE, IOWA:

That on this the 28th day of August, 1972, the Council of the Town of Fontanelle, Iowa met in special session for the purpose of a hearing upon the budget estimate as filed with this Council. There was present a quorum as required by law, thereupon the Council investigated and found that the notice of the time, place of hearing had been in accordance to law and as directed by the Council, been published on the 10th day of August, 1972, in the Fontanelle Observer, a newspaper published at Fontanelle of said county and that the affidavits of publication thereof were on file with the County Auditor. Thereafter on said day the estimate was taken up and considered and taxpayers heard for and against said estimate as follows: None appearing.

The Council took up the estimate for final consideration and after being fully advised the Council determined that said estimate be completed so that when completed it should be in words and figures as stated herein:

That the Budget for the Town of Fontanelle, Iowa for the year 1973 be adopted as filed, in the amount of \$273,830.

The vote on the final adoption of this Resolution 8-1972 was unanimous.
