Section 2. Hours, Holidays and Overtime. Overtime will be paid at the rate of time and one-half to Employees, Gene Dillon and Frank Rice for the time spent beyond the regular eight hour day when designated by the foreman. The employees will work 40 hour week plus stand-by and starting the pumps on a rotation basis. Foreman Delmer Miller will receive overtime pay on projects designated by the Council. He may take compensatory time for hours worked if taken within 5 working days.

Employees Delmer Miller, Gene Dillon, Frank Rice, Dorvin McIntosh and Lorraine Homan will be allowed seven paid Holidays per year. Paid Holidays shall be New Years, Christmas, Memorial, Independence, Veterans, Labor and Thanksgiving. Said Employees must use their vacation within the year. The employees will be allowed to accumulate 90 days sick leave.
