Frank Rice submitted his resignation effective May 15, 1975.

Motion by Leo Armstrong to pay Shirley Jorgensen \$2.00 per hour for hours worked. Seconded by Dean Darrow. Carried.

Council members interviewed some applicants for job openings.

Motion by Leo Armstrong to hire Rodney Stoner for park custodian and part time Marshall starting May 15, 1975, for at least 50 hours per week, at an annual salary of \$6890.00, and under the supervision of Don Rivers. Seconded by Dean Darrow. Carried.

Motion by Dean Darrow to adjourn. Seconded by Leo Armstrong. Carried.
