Councilman Westphal gave a report on the Well Water Project.

Councilman Art Baudler introduced Resolution No. 76.16 entitled "Resolution Approving Street Construction for July 1, 1976 to June 30, 1977" and moved for its adoption. Keith Westphal seconded the motion to adopt. Roll was called and the vote was AYES: Bond, Baudler, Darrow, Means and Westphal. NAYS: None.
