Mr. Kitchell related that only COUNTYS are immune to Errors & Omissions not City Governments. He thoroughly explained the Specifications which are in book form, relating what each policy was for. A complete list of Special Equipment which is covered by Inland Marine Insurance has to be made. Anything under \$1000 value should not be listed. In order to save on the price of insurance, Mr. Kitchell suggested \$1000 deductible on most policies.

Roger Candee met with the Council to request that City Water be hooked up at his residence, anytime the City can do it. A decision as to where to hook on to the main will have to be established.
