Bill Blazek ask the Council's permission to hold a Hillbilly Flea Market sometime in the near future. He stated that they would like to have it on a Sunday and would need two sides of the square. Those bringing things to sell usually pay \$3.00 per set up, and are ask to clean up after the sale is over. If it goes well, then he would like to hold two or three a year, but would like to hold the first one either right before or right after the County Fair. This would be held in the daytime so no extra lighting would have to be provided for.

Motion by Robert Weiland that Bill Blazek be in charge of promoting, advertising and collecting registration fees for the Hillbilly Auction to be held on Sunday July 17th with the provision that "NO GUNS" will be allowed to be sold. Money received for registration fees will be used to pay for advertising and any money left over after that will be split 50-50 between Mr. Blazek and the City. Seconded by Perry. Carried.

Wages were discussed. No decision was reached and the matter was tabled until the June 9th meeting.

Fontanelle, Iowa

The City Council met in Special Session at the City Hall at 7:30 p.m. with Mayor Ralph D. Means presiding. Council Members present were: Harold Veatch, Denny Sickles, Kenneth Perry, Gene Jacobsen and Robert Weiland. Absent: None.

The Council met with Terry Lutz of McClure Engineering and with Mr. Richard McClanathan of the Southern Iowa Council of Governments.

Mr. McClanathan explained the State and Federal Guidelines that must be followed when receiving Grant monies. Letters are to be sent out to several Engineering firms for requests for proposals and qualifications. At this meeting the Engineer is to be hired on qualifications not dollar amounts. A Bonding Attorney usually wants to look over the amount of dollars to be spent on a building project. Mr. McClanathan stated that the Mayor would be receiving a package with 4 Or 5 letters with forms to fill out that must be back by June 22nd.

If the Bond issue should fail the Grant money would have to be returned.

Section 2E is not included within the Contract with Southern Iowa Council of Governments. The proposed contract would be in the amount of \$7,000.

ALL DUPLICATE FILES MUST BE RETAINED FOR 3 YEARS. \$1,000. is included for audit purposes and \$1,000 can be used by the City to reimburse for calls, milage etc. It does provide for termination at the City's descretion.

Motion by Denny Sickles to approve the Contract with Southern Iowa Council of Governments and to approve the Administration fees not to exceed \$7,000. Seconded by Harold Veatch. Carried.

SICOG is to send out a letter to several Engineering Companies. A Special Meeting will be held on June 27th at 7:30 p.m. to interview the different Interested Engineering firms.

Ordinance No. 115 was re-introduced for the second consideration.

Motion by Robert Weiland to waive the 3rd reading. Seconded by Gene Jacobsen. Carried.

Motion by Denny Sickles to finally adopt the Ordinance. Seconded by Harold Veatch. Carried.

Roll Was called and the following voted: AYE: Harold Veatch, Gene Jacobsen, Kenneth Perry, Denny Sickles and Robert Weiland. NAYS: None Whereupon, the Mayor declared the Ordinance duly adopted.

AN ORDINANCE GRANTING TO THE UNITED TELEPHONE COMPANY OF IOWA, ITS SUCCESSORS AND ASSIGNS, THE RIGHT TO CONSTRUCT, ERECT, MAINTAIN AND OPERATE WITHIN THE CITY OF FONTANELLE, IOWA, PLANT STATIONS OR WORKS FOR THE FURNISHING TO THE CITIZENS OF THE CITY OF FONTANELLE, IOWA, TELEPHONE AND COMMUNICATIONS SERVICE WITHIN SAID CITY AND THE SURROUNDING TERRITORY; TO CONSTRUCT, OPERATE AND MAINTAIN CABLES, LINES OR TRANSMISSION AND TOLL LINES TO USE THE STREET, ALLEYS AND PUBLIC GROUNDS OF SAID CITY OF FONTANELLE, IOWA, NOW OR HEREAFTER LAYED OUT OR CONSTRUCTED FOR THE PURPOSE OF SUPPLYING THE CITIZENS OF THE CITY OF FONTANELLE, IOWA, AND THE CITY AND ALL CORPORATE AND PRIVATE CUSTOMERS OF THE SAID CITY WITH THE SAID COMMODITIES; AND TO ERECT AND MAINTAIN ON SAID STREETS, ALLEYS AND PUBLIC GROUNDS, CABLES OR OTHER TRANSMISSION LINES THROUGH THE CITY OF FONTANELLE, IOWA, TO SUPPLY COMMUNITIES AND INDIVIDUALS OUTSIDE OF SAID CITY WITH SERVICE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FONTANELLE, IOWA AS FOLLOWS:

SECTION I

FRANCHISE: That United Telephone Company of Iowa, a corporation, its successors and assigns, (hereinafter called Grantee) be and it is hereby granted and vested with the right, franchise and privilege for a period of 25 years from and after the adoption and approval thereof on the 9th day of June, 1983, as provided by law, to acquire, construct, maintain and operate in the City of Fontanelle, Iowa, the necessary facilities for the furnishing of telephone service for public and private use; and to construct and maintain along, upon, across or under the streets, highways, avenues, alleys, bridges and public places the necessary fixtures and equipment for such purposes.

SECTION II

CONSTRUCTION REGULATED: The work of erecting poles by virtue of this ordinance shall be done under the supervision of the Grantee and said Company shall replace and properly relay any sidewalk or street that may be displaced by reason of the erection of such poles, and upon failure of the Company to do so, after twenty (20) days notice in writing shall have been given by the Mayor of said City to said Company, the City may repair such portion of the sidewalk or street that may have been disturbed by said Company, and collect the cost so incurred from said Company.

SECTION III

NOT EXCLUSIVE: This franchise shall not be exclusive and shall not restrict in any manner the right of the City Council, or other governing body of the City in the exercise of any regulatory power which may now or hereafter be authorized or permitted by the laws of the State of Iowa.
