The City Council met in special session at the City Hall at 7:00 p.m. with Mayor Pro-Tem Harold Veatch presiding. Council Members present were: Denny Sickles and Robert Edwards. Committee Members present were: Roger Candee, David Homan, Harvey Wallace Delmer Miller and Steve Marckmann.

It was for the purpose of meeting with Mr. Overfelt of Kansas City.

Mr. Overfelt stated that he had been in business with Cable for a year and a half. His family also operates a computer service. At present he has 4 cable franchises. He stated that the franchises run for 15 years with an option to extend it 5 more years. They offer 11 basic channels and 1 premium. The charge for the basic 11 is \$10. per month and the movie Channel is another \$10. A one-time hook charge is \$25. but there is no extra monthly charge for the extra sets that one has in their house.

The committee and Council stated that a franchise election would have to be held, and the charge of election would have to be paid by the Satellite Co. He presented the Council with a copy of the Ordinance for the Franchise and reviewed all points with the Council and committee.

The company would pay a franchise tax of 3% on the gross-net, and any leasing of poles would be paid for. A full time repair man from Rockport, Missouri would take care of repairs. The Council stated that they preferred the Cable be underground but Mr. Overfelt prefers overhead where possible.

Mr. Overfelt said that his company does all their own billing, with the payment remitted by mail.

If more Channels are desired, their is a \$30. deposit on the selector box.

Motion by Roger Candee of the Cable T.V. Committee to suggest to the City Council that they consider the Franchise with C.R.O. Satellite Service Inc. for the 15 year franchise, with the option to buy back at the end of the 15 years. Seconded by Harvey Wallace, Committee Member. Carried.

Motion by Steve Marckmann to adjourn. Seconded by David Homan. Carried.
