The City Council met in Special Session at the City Hall at 7:30 p.m. with Mayor Ralph D. Means presiding. Council Members present were: Gene Jacobsen, Denny Sickles, Kenneth Perry, Robert Edwards and Harold Veatch. Absent: None.

Purpose of the meeting was to discuss what should be done about the Transformer and also to have Mr. and Mrs. Roy Davis have another hearing on their Liquor License for the Double D Lounge.

Motion by Kenneth Perry to approve the Agenda as posted. Seconded by Denny Sickles. Carried.

Delmer Miller explained to the Council that he was not really prepared for the discussion as he had not received any information from Solomon Electric or Westinghouse. U.S. Transformer Co. had given Delmer some quotes. They had 3 single transformers at \$5,000. each. Delivery would be in 2 or 3 weeks and they had a warranty of 18 months. They did not say if lightning arrestors were on these. If not, there would be an additional cost. They would re-wind the Westinghouse for \$22,500. However, Delmer related that if they were going to have it rebuilt he thought it would be better to send it directly to the Westinghouse factory. A new G.E. would have a 20 week delivery date. Delmer said that a different type of reclosure might detect a ground fault quicker, but he felt that something in writing from an Engineer stating that the protection was correct was very necessary.

Roy and Anna Davis met with the Council on a hearing for their Liquor License and Sunday Sales permit. Mr. Davis explained that the reason they had not paid their prior utility bill was that he was on a very heavy pain pill and had gone to a pain clinic. The Mayor read the reason for the denial of the first application which was upheld by the State Liquor Commission, and put the question before the Council as to what their decision was to be on this hearing.

Motion by Denny Sickles to approve the application of Anna L. Davis dba Double D. Lounge for a Liquor License and Sunday Sales Permit with a substantial deposit to be paid. Seconded by Robert Edwards. Motion did carry with Gene Jacobsen and Kenneth Perry voting Nay.

Motion by Denny Sickles to approve a Cigarette Permit for Anna L. Davis dba Double D Lounge. Seconded by Harold Veatch. Carried but with Gene Jacobsen voting Nay and Kenneth Perry not voting.

Motion by Robert Edwards to adjourn. Seconded by Denny Sickles. Carried.
