

The City Council met in an Emergency Session at the City Hall at 5:30 p.m. with Mayor Ralph D. Means presiding. Council Members present were: Albert Ehrenfried, Robert Edwards, Kenneth Perry, Sally Sorensen and Gene Jacobsen. Absent; None.

The purpose of the meeting was to meet with Pat Patterson of Western Engineering. The streets that the Council had wanted resurfaced were: Maple Street for South 1st to 9th Street; 5th street from Highway 92 to Maple Street; 6th Street to Maple Street; Jefferson Street from 6th to 8th Street; 3rd Street from Benton to Summerset; Scott Street from 4th Street east to 5th street and 1/2 block south on 5th Street. Mr. Patterson estimated that it would take approximately 2,094 ton. This cost is around \$34.74 per ton or a total cost of \$72,485.

Mrs. Frisbie ask permission to put in a Handicap availability entrance to her store. The Council will take this up at their next regular meeting.

Motion by Kenneth Perry to approve Al Mensing's building permit to put a new front on the bar which had been damaged by wind. Seconded by Albert Ehrenfried. Carried.

The Council gave permission to have the sidewalk surrounding the new water tower put in clear to the curb.

Motion by Sally Sorensen to approve the Finance Report as given. Seconded by Robert Edwards. Carried.

Motion by Leroy Nelson to pay the bill for 10 pieces of 2 1/2" hose. Seconded by Roger Frank. Carried.

Chief Ray Stewart reported that they had tested hoses by pressure checking them and 7 of them blew out. He also stated that the department would like to apply for a 50-50 grant from the Department of Natural Resources for 10 helmets, 5 coats and 3 pair boots. The helmets are \$60. each, Coats \$165. Each and Boots are \$55. a pair. The Mayor signed the application for the grant.

There was discussion about the placement of the fire whistle. It had been 65' in the air. The chief said that if it was any lower that it could not be heard. They talked about putting it on a pole, or a 4 legged tower could be put on the old fire station. The committee suggested that someone should check into the best place and what to use to hold the whistle.
