

Mark Fincel of H. R. Green, presented two bills. Motion by Armstrong to pay these bills. Seconded by Tiedeman. Carried.

After due consideration and discussion, Councilman Tiedeman introduced and moved for the adoption of a resolution approving contract and performance and/or payment bonds for the Water Pollution Control Facilities. Seconded by Hepler. Carried. Roll was called and the following voted AYE: Pitts, Tiedeman, Armstrong and Hepler. NAY: None. Whereupon, the mayor declared the resolution duly adopted as:

RESOLUTION 92.8

APPROVING CONTRACT AND PERFORMANCE AND/OR PAYMENT BONDS FOR THE WATER POLLUTION CONTROL FACILITIES

The contracts were then dated and signed by the Mayor and clerk. Al Kunkel of SICOG, presented and administrative bill and a draw down for grant funds. Motion by Pitts to have the Mayor sign the draw down. Seconded by Hepler. Carried.

Four building permits were presented to the council. 1. Dallas Sickles for a porch 2. Dennis Tanner for a garage 3. Ramon Jacobson for a 2-story garage 4. Tom Purdy for a pole barn and a garage. Motion by Tiedeman to approve all four building permits. Seconded by Pitts. Carried.

At 8 pm the Public Hearing to hear arguments for or against the adoption of the new code was opened. No citizens attended the Hearing. After due consideration and discussion, Councilman Armstrong introduced and moved for the adoption of an ordinance adopting the new code. Seconded by Hepler. Carried. Roll was called and the following voted AYE: Pitts, Tiedeman, Armstrong and Hepler. NAY: None. Whereupon, the Mayor declared the ordinance duly adopted as:

ORDINANCE 132

AN ORDINANCE ADOPTING THE "CODE OF ORDINANCES OF THE CITY OF FONTANELLE, IOWA, 1992"

The public hearing was then closed and the regular meeting resumed.

Motion by Tiedeman to approve the new board appointments to the library. Seconded by Armstrong. Carried.

Lawn service proposals were viewed and discussed. Motion by Armstrong to accept Rabe Turf Care with fertilizer and weed killer service first, with a fall aeration. Seconded by Pitts. Carried.

Motion by Hepler to approve the street committee's recommendation of streets to be done this year by Blacktop Service, after a meeting with John Fox. Seconded by Armstrong. Carried.

Departmental reports were heard and correspondence read.

Delmer reported that some work needed to be done to the rides in the park. He is to see that this is done.

The Lutheran Church would like to close the street in front of the church again this year during Bible School. This would be the week of June 15th and would consist of closing for approximately an hour in the morning and an hour in the afternoon.

Chief Smith's monthly report was submitted for review.

Motion by Pitts to approve a donation to the League towards the Iowa Municipal Salaries and Benefits book. Seconded by Armstrong. Carried.
