Motion by Thompson to award the contract to Push, Inc. for plowing in the line with DGR providing observers. Seconded by Tiedeman. Carried unanimously.

DGR also recommended the padmount switching materials be awarded to Electric Materials for \$17,360.45. Another bid was lower but after

reviewing all bids it was discovered that the lower bid did not include some necessary fuses or freight charges, which would make it higher than the bid from Electric Materials.

Motion by Armstrong to award the materials contract to Electric Materials. Seconded by Thompson. Carried unanimously.
