Ron Herr had prepared a budget for the 2002/2003 fiscal year and a cash flow chart for the last four years. Welsch made a motion to approve the budget as presented. Mensing seconded the motion. Carried unanimously.

Fire Chief Sickles reported that all nine firemen had passed the Firefighter 1 test. Mayor Homan commended the firemen for their time and effort involved in taking the class. Sickles also reported there will be a considerably more grant money available this year than was available in past years. He is in contact with FEMA already concerning this. He is also working on some additional training for the fire department.

Baudler made a motion to adjourn the meeting at 7:25 p.m. Dukes seconded the motion. Carried unanimously. The next meeting will be March 28, 2002 at 7 p.m.
