Green is recommending doing compaction testing to ensure everything is correct. The city crew has been working on leveling manholes before the blacktop company arrives. Nathan reported he had received a complaint about some evergreen bushes blocking a street corner. Susan stated she spoke to the property owner Monday morning regarding these bushes.
