Mayor Sickles declared the public hearing open for proposed contract for new transformer, open at 7:01pm.

Jarrod Luze presented the two bid on the new transformer and recommends Howard Industries with an extra 5 year warranty.

Mayor Sickles declared the public hearing closed for proposed contract for new transformer, closed at 7:07pm.

Motion by Davis to award contract with Howard Industries transformer bid with 5 year warranty in the amount of \$210,100.00, 2nd by Dukes. Approved

Jarrod Luze gave a quick update on the substation project. He noted that a new CT Connection will need added, and will be arranging for a crane to come in to unload new transformer and salvage the old one.
